WHEREAS, the East Niceville Fire District of Okaloosa County, Florida, on September 7, 2022 adopted Fiscal Year 2022-2023 Tentative Milage Rates following a public hearing as required by Florida Statute 200.065 and

WHEREAS the East Niceville Fire District of Okaloosa County, held a public hearing as required by the State of Florida as required by Florida Statute 200.065 and

WHEREAS the gross taxable value for operating purposes not exempt from taxation within the East Niceville Fire District has been certified by the County Property Appraiser as \$464,904,785

NOW THEREFORE, BE IT RESOLVED by the East Niceville Fire District of Okaloosa County, Florida, that:

1. The Fy2022-2023 operating millage rate is 3.4000 mills, which is greater than rolled back rate of 2.7809 mils by 22.26%
2. This ordinance will take effect immediately upon its adoption.
